

OFFICIAL CONTEST RULES  
"Fall Fix-Up"

**1. How to Enter the Contest:**

The Fall Fix-Up contest will begin on August 20, 2023, and end on October 13, 2023.

- a. No purchase necessary.
- b. To participate in the contest, participants must register before October 12, 2023 at 4pm for a chance to be a Finalist by going to either <http://www.majic951.com> or <http://www.classichits1017.com>. A computer or mobile device with internet connection is required to register online and is the responsibility of the contestant to provide to participate, upon meeting eligibility restrictions.
- c. Complete and submit the online entry form, including your first name and last name, complete address, city, state, zip code, home telephone number and a valid e-mail address in the online entry form. Online entrants are subject to all notices posted online including but not limited to the station's privacy policy.
- d. Participants may also register to be a Finalist at Windows, Doors & More beginning August 29, 2023, by scanning the QR code on display or completing a paper entry for an additional chance to be a Finalist. To enter on location, scan the online QR Code linked to <http://www.majic951.com> or <http://www.classichits1017.com> and follow the link and instructions to enter the contest. Limit one (1) additional entry per person. Only 2 total entries per contestant permitted during the contest.
- e. A contestant may only enter with one email address regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. boxes are not permitted. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator. By the use of the Station website and by entering this contest, contestants agree to Station's website user agreement and privacy policy as described on at <http://www.majic951.com> and <http://www.classichits1017.com>.
- f. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.
- g. Participants that complete a hand-written entry including the contestants name, address, city, state and phone will only be accepted at the Windows, Doors and More Showroom at 1121 W. Washington Center Rd.
- h. Contestants can be a Daily Finalist in the contest beginning September 05, 2023.
- i. Contestants will have an additional opportunity to be a finalist and win a qualifying prize on WLDE by listening to their name on-air each weekday during the contest dates at 2:20 p.m.

**Eligibility Restrictions:**

- a. The contest is open to anyone who is 18 years of age or older and reside in the Fort Wayne metropolitan area, consisting of Adams, Allen, Dekalb, Huntington, Noble, Steuben, Wells and Whitley counties in Indiana, along with Paulding and Van Wert counties in Ohio.
- b. Employees of Sarkes Tarzian Inc., Windows Doors & More, including current and former employees of independent contractors or current or former spokespersons, as well as employees of radio stations in the Fort Wayne Metro, and members of their respective families are not eligible. Family is defined as parents, in-laws, children, spouses, people in spouse-like relationships and siblings, including those in step and half relations. Anyone who has been employed by or interned with Sarkes Tarzian, Inc., is also ineligible.
- c. You must be a homeowner, with a house on a permanent foundation, not a renter, to be a winner. The house cannot be a trailer, mobile home or modular home.
- d. Homes must meet requirements set by all manufacturers for installation of their products. Failure to meet these requirements will require additional costs which must be paid by the winner.
- e. Persons who have won prizes of cash or merchandise totaling \$600 or more from WLDE/WAJI since February 20, 2023, are ineligible for this contest.
- f. You may win only once during this contest.
- g. Only one finalist per household is permitted.

**3. Prizes:**

\$15,000 in Home Improvements from Windows, Doors & More will be awarded on October 13, 2023.

- a. Prizes are not transferable and may only be redeemed for cash if the Cash Option for a prize is necessary. There are no exchanges at the request of the winner.
- b. The Grand Prize must cover design service, permits, installation, materials and labor.
- c. Grand Prize exclude decks and all hard surface countertops at Windows, Doors & More, including but not limited to granite, marble, soapstone and quartz.
- d. The winner of the Grand Prize must claim the prize through WLDE/WAJI within 2 weeks of winning by signing the Station's Receipt for the construction of the Plan. Winners must make their decision of home improvements within 1 month of the date on the Station's Receipt. Their decisions have to be a workable plan in the sole opinion of Windows, Doors & More. ("The Plan"). If the winner cannot arrive at a Plan, then Windows, Doors & More will award the winner the Cash Option. The winner must make all necessary arrangements with Windows Doors and More for the construction of the Plan within a period of one year from the date of receipt.

- e. If the winner cannot come to an agreement on the Plan with Windows, Doors and More within 30 days of signing the Receipt, they may opt out of the Grand Prize and take the cash option instead, thereby, forfeiting all of the home improvement options. The cash option is as follows for the Grand Prize.
  - 1. Cash option prize is \$3,000
- f. If the Grand Prize Winner cannot take possession of the Grand Prize due to force majeure, major difficulties in construction, product availability or any other reason beyond the reasonable control as determined by Windows, Doors & More and WLDE/WAJI management in their sole discretion, Grand Prize Winner shall receive the cash option prize.
- g. Qualifying prizes may vary and will be valued at approximately \$10.00

**4. Selection of Winners:**

- a. At approximately 8:50 a. m. each contest day beginning 9/05/23, one contest entry will be randomly selected from all contest entries taken at [www.classichits1017.com](http://www.classichits1017.com), [www.majic951.com](http://www.majic951.com) and at Windows, Doors & More as a Daily Finalist for the Grand Prize.
- b. Contestants will have a “Bonus Chance” to be a Finalist in the contest at 10:20 a.m., and 3:20 p.m. each contest day on WLDE, Classic Hits 101.7 FM. One contest entry will be randomly selected from all entries received each time. The contestants name selected will be announced on-air and that person will have 10 minutes and 7 seconds to call (260)-426-5343 to become a Finalist in the contest and win a participation prize. If the contestant does not call back in the allotted time, they will not be a Finalist or win a participation prize. But their name will remain eligible to be selected again during another contest episode, including the Daily Finalist.
- c. A contestant can only be a Finalist one time during the contest.
- d. All Finalists in the contest are eligible for the Grand Prize drawing, meeting eligibility restrictions.
- e. A total of 81 contestants will be randomly selected from all online and in-store entries received during the contest dates. The total number of Finalists for the Grand Prize drawing depends on the number of Finalists that qualify on-air on WLDE, Classic Hits 101.7, that are added to the 27 Daily Finalists.
  - 1. One Grand Prize winner will be determined by random drawing from all eligible Finalists taken during the contest and selected on 10/12/23 at 5p. The Grand Prize winner’s name will be announced on-air on 10/13/23, at approximately 8:20a, on-air.
- f. The Grand Prize winner will be posted online at [www.classichits1017.com](http://www.classichits1017.com) and [www.majic951.com](http://www.majic951.com), and a WLDE/WAJI representative will attempt to contact each winner by telephone. If a winner cannot be reached within 5 business days, an alternate winner will be selected.

**5. Conditions:**

- Decisions of WLDE/WAJI management with respect to the contest are final.
- a. Payment of all federal, state and local taxes is the sole responsibility of the winner. Winners will be reported to the IRS, on IRS Form 1099 or the equivalent if applicable.
  - b. By participating in the contest, the winner agrees to allow their name, voice and/or likeness to be used in any advertising or broadcasting material relating to this contest for a period of one year without additional financial or other compensation.
  - c. Contest winners are required to sign a receipt verifying eligibility prior to acceptance of any prize of more than nominal value. Before claiming a prize, contest winners are also required to sign a liability release if the prize to be awarded is valued at \$600 or greater, if the contest or prize includes the provision of transportation, whether or not such transportation is provided by WLDE/WAJI. Pursuant to the Liability Release, the winner will agree to hold WLDE/WAJI, Sarkes Tarzian, Inc., Windows, Doors & More and the respective officers, shareholders, directors, employees, agents and representatives of each of them harmless from and against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
  - d. WLDE/WAJI in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of any station web site or who is otherwise in violation of the rules. The station further reserves the right to cancel, terminate, or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
  - e. These rules are subject to the interpretation of WLDE/WAJI. Any aspect of these rules, including the substitution of a prize or prizes of equivalent or greater value, can be changed at the discretion of station management, and such changes will become effective upon on-air or other appropriate announcements.
  - f. No purchase is necessary. This contest is void where prohibited.
  - g. Failure to comply with the contest rules may result in a contestant's disqualification, at the sole discretion of WLDE/WAJI.
  - h. WLDE/WAJI are not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call when necessary.
  - i. WLDE/WAJI is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcements of any prize.
  - j. The prize amount won by a contestant cannot be applied to any past purchase, or any current purchase that has already been agreed upon by a participant with Windows, Doors and More prior to winning the contest. The Grand Prize amount would be a new agreement that is separate from any other arrangements that currently exist between a contestant and Windows, Doors & More.
  - k. As a consequence of delays in the online streaming of the WLDE/WAJI signals compared to over-the-air broadcasts, online listeners may be at a disadvantage in
